**Emilija Banionyte** is a professional librarian. After graduating with a degree in Library Information Science (LIS) from Vilnius University in 1984 she started working at the Lithuanian University of Educational Sciences Library as Head of the Acquisitions Department. In 1987 she became Library Director.



Emilija is active in professional librarianship not only in Lithuania, but also internationally. Her special fields of interests are library consortium building, licencing electronic resources, and copyright for librarians. She is the President of the Lithuanian Research Library Consortium (since 2001), member of the Protection of Intellectual Property Rights Board of Lithuania, EIFL IP coordinator for Lithuania, and member of the EIFL Management Board. In the past, she has been President of the Lithuanian Librarians' Association, member of the EIFL Advisory Board, member of the Board of Directors of SPARC Europe, member of the EBLIDA Expert Group on Information Law, and member of the IFLA CLM Committee. She is also currently managing the EU Structural Funds, a funded 4-year project called "Opening research databases for

Lithuania – Stage3". Emilija is fond of skiing, sailing and travelling.

In August 2017 Kyrgyzstan became a first country in region of Central Asia where the Marrakesh Treaty came into force. Current time Sania Battalova is working in St.Petersburg State Library for the Blinds to announce and implement new services, and to extend access to information for blind and visually impaired people.

Her commitment



and strong advocacy skills has helped make EIFL a leading voice for copyright law reform in developing and transition countries at the international level. With extensive experience working with libraries on legal information issues and advocating for copyright reform with policy-makers, Teresa is a frequent contributor at conferences and events around the world.

Prior to joining EIFL, Teresa held a number of policy, advocacy and technical positions. From 2000-2003, she was Director of the European Bureau of Library, Information and Documentation Associations; before

that she provided support to the European Commission library research programme, and was part of the team that established electronic information centres at the British Council in Germany. Arnold Hirshon has been the Associate Provost and University Librarian at Case Western Reserve University since 2010. During his tenure he has undertaken a large renovation of the library, including greatly expanding the digital scholarship center, and built an organizational culture of experimentation, design thinking, and assessment. Previously he was Chief Strategist and Executive Consultant for LYRASIS, and for ten years he was Executive Director of NELINET, a library consortium that provided consulting, digital services, and open source software support services.

Prior to NELINET, Arnold served as Vice Provost for Information Resources (Chief Information Officer) at Lehigh University, where he was responsible for university computing and libraries. Previously, he was University Librarian at Wright State University, Associate Director of Libraries at Virginia Commonwealth University, and in library administrative posts at Duke University and Wayne State University. Arnold is a Past President of the Association for Library Collections & Technical Services.

A highly experienced international consultant on issues of organizational, strategic and business planning, facility redesign, operations management and assessment, and technology integration. Arnold has been a consultant for EIFL since 2000. Arnold has an extensive scholarly record that includes many monographs, including the LYRASIS Library Strategic Planning Toolkit (co-author: Stephen Spohn), and the author of numerous articles about strategic management, technology and library leadership, information service integration, assessment and optimization of operations, and non-profit management. A frequent lecturer nationally and internationally, Arnold

has given numerous lectures on a wide range of topics, including organizational management, trend spotting and analysis, technology planning, and operations assessment and optimization.

## **EIFL-OA Programme Manager**



Iryna Kuchma is the Open Access Programme Manager for EIFL. Iryna has been managing the Open Access programme since 2008. Her responsibilities include the development, delivery and evaluation of a range of open access related activities.

Under Iryna's management, the Open Access Programme has many achievements, including the establishment of more than 900 open access repositories and more than 4,000 open access journals in

EIFL's partner countries. The programme also supported the development of 96 open access policies in EIFL partner countries, opening up a wealth of new knowledge and research into the world. An expert on open access in developing and transition countries, Iryna is frequently asked to speak at conferences and open access events around the world.

Before joining EIFL, Iryna worked as an Information Programme Manager at the International Renaissance Foundation (part of Soros Foundation network in Ukraine) and also coordinated the Arts and Culture Programme there.

Iryna is a member of Directory of Open Access Journals (DOAJ) Advisory Board, DSpace Community Advisory Team (DCAT), NDLTD (Networked Digital Library of Theses and Dissertations) Board of Directors, the Open Library of Humanities Internationalisation Committee, Electronic Publishing Trust (EPT) Trustee and the Open Access Button Steering Committee.

Iryna also chairs a Working Group 'Repository and Repository Networks Support & Training' in the Confederation of Open Access Repositories (COAR) and participates in a Joint ARL/CARL/COAR/LIBER Task Force on Librarians' Competencies in Support of E-Research and Scholarly Communication.

From 2009-2010, Iryna was a Steering Committee (and Task Group) member, InterAcademy Panel (IAP) on International Issues Programme dealing with Digital Knowledge Resources and Infrastructure in Developing Countries. She has also served on the Access to Learning Award (ATLA) Committee of the Bill and Melinda Gates Foundation's Global Library Initiative.

In 2013, Iryna received the Electronic Publishing Trust (EPT) for Development Annual Award, in recognition of her "efforts in the furtherance of open access to scholarly publications in the developing and emerging countries". Iryna has an M.A. in Cultural Studies from the National University 'Kyiv-Mohyla Academy', Ukraine. Languages: Ukrainian, English, French, Polish, Russian.

Rima Kupryte is the Director of EIFL. Rima oversees the implementation of EIFL's overall organisational strategy and operations. Rima has been managing EIFL since its inception. Marika is also the Head of the Estonian Research Information System at the Estonian Research Council.

Since 1998 Marika has been heavily involved in the process of acquiring electronic and digital information in Estonia, and has been leading a

taskforce responsible for coordinating the acquisition of electronic resources in Estonia.

In 2001 Marika became involved in building and administrating an Estonian Current Research Information System. This was the first in-house designed national CRIS system, designed by the Archimedes Foundation. Since 2012, Marika has been administrating the Estonian Research Information System at the Estonian Research Council. She has also been participating in an Open Science Task Force.

### Joseph McArthur

#### Co-Lead/Founder, Open Access Button



Joseph McArthur is the Assistant Director of the Right to Research Coalition, SPARC's student initiative. Joe is responsible for organizing and amplifying the student voice to advocate for policies promoting open research and education across the EU and beyond. Joe works to further strengthen and leverage the Right to Research Coalition's engagement with its membership of more than 90 student organizations, which collectively represent nearly 7 million students in over 100 countries around the world. He also supports preparations for Open Access Week

and OpenCon in addition to leading OpenCon's community and satellite event initiatives, to ensure the conference has a year-round, global impact.

Prior to joining SPARC, Joe co-founded the Open Access Button, a suite of tools to get access to articles behind paywalls, either by finding free, legal alternatives or requesting an author make a copy available. The project has gained significant attention both within and beyond the Open Access community. Joe continues to lead the Open Access Button, which is supported by SPARC.

Joe studied Pharmacology at University College London, worked for the pharmaceutical industry, and has many years of experience leading student organizations.

#### Diana Sayej-Naser

#### Library Director, Birzeit University Main Library, Palestine



Diana received her Masters in Library and Information Science in 1983 from the University of Indiana in the US, and has subsequently held a variety of positions in libraries in Palestine. In 1998 she became Library Director at the main library at Birzeit University.
